



Sir: -

Re: Chinese labour trouble, Penticton.

In accordance with your instructions, I have recently visited Penticton to enquire into the above matter.

The Southern Okanagan Land Company, who are operating what is known as the Ellis ranch, at Penticton, during the month of March last, imported ten Chinese to clear land.

Shortly after the arrival of the Chinese at Penticton they were driven out of town, in the night time, by a band of about thirty white men who placed them on board of the steamer "Aberdeen" and returned them to Kelowna. He victence was used and no person was injured.

Shortly after my arrival at Penticton, Mr. W. T. Shatford, managing director of the above named Company, caused an information to be laid, under section 523 of the Criminal Ecde, charging size of the white men, namely:-

> George E. Winkler James Mitchell G. S. Gladden James Edmonds G. S. Mohr and A. C. Judd

with intimidation. The charge was disposed of summarily, by consent of each of the accused, who were tried by four of the resident Justices of the sitting together.

Mr. Fred. Billings, of Vernon, appeared for the private prosecutor. The accused persons, with the exception of A. C. Judd - who was discharged, were convicted and fined twenty-five dollars each or imprisonment in Kemloops gaol for a term of one month. G. S. Mohr paid his fine, and Winkler, Mitchell, Gladden and Edmonds were removed to Kemloops Gaol by myself without other police escort.

The prisoners will be kept separate from other prisoners and, as this is their first offence and the men are not sentenced to hard labour, I have instructed the Warden to allow them to wear their own clothing during their term of imprisonment unless otherwise directed.

The conduct of the prisoners on their way to gaol was excellent.

I believe it is the intention of the Southern 1 Okanagan Land Company to again employ Chinese labour, as they claim that they esmot afford to pay the price demanded by white men for clearing land.
